- » Server Monitoring
  - Email, Teams and SMS notifications



### **County/Agent**

#### **IT UPDATE - Security Enhancements** User Security

- Logout Enforcment
  - Logout all APEX logins nightly
  - Timeframe: 30-90 days
- Inactive User Suspension
  - Suspending inactive users (>90 days)
  - Timeframe: 30-90 days
- » Authentication Changes MFA
  - Authenticator App/SMS/Dongle
  - Personal Device Required?
    - Timeframe: 9-12 Months
